


**COUNTY OF MUSKEGON  
AND  
WHITE LAKE AREA CHAMBER OF COMMERCE  
TOURISM AGREEMENT**

This Agreement is entered into effective the 1<sup>st</sup> day of October, 2012, by and between the County of Muskegon, hereinafter referred to as "County", and the White Lake Area Chamber of Commerce, hereinafter referred to as "Chamber", a not-for-profit corporation serving the White Lake, Muskegon County area.

**RECITALS**

- A. Muskegon County, by and through its Board of County Commissioners, has levied and is responsible for the governance, management, and administration of accommodation tax revenues which the County Board has chosen to utilize for the support of convention and tourism activities in Muskegon County.
- B. The Chamber for many years has also been involved in maintaining a tourism center and pursuing other activities relating to the tourism and convention promotion of Muskegon County Interests.
- C. The Board has appropriated funding to the Chamber in support of continuing efforts in such regards.
- D. The Board by law is required to provide oversight with regard to the expenditure of such appropriated funding.
- E. The Board desires that Tourism Promotion and activities be well coordinated and non-duplicative.

NOW, THEREFORE, IN CONSIDERATION OF MUTUAL COVENANTS AND CONDITIONS HEREINAFTER SET FORTH, THE PARTIES HEREBY AGREE AS FOLLOWS:

Section 1. Appropriation and Disbursement of Funding. The County of Muskegon agrees to disburse for the fiscal year 2013, (i.e. the period October 1, 2012, through September 30, 2013), a total amount not to exceed Seventy-Eight Thousand, Five Hundred Dollars (\$78,500) and the Chamber hereby agrees to utilize such funding only in accordance with the provision hereinafter set forth.

The entire funding provided to the Chamber shall be spent on advertising and promotion. Furthermore, the expenses must have the approval of the Chamber Board of Directors.

The parties agree that Seventy-Eight Thousand, Five Hundred Dollars (\$78,500) shall be disbursed by the County in four equal, quarterly installments.

The Annual advertising plan for the ensuing year shall be provided to the County Board annually for their review and input before expenditures are incurred.

It is understood and agreed by the parties that when practicable advertising and promotional materials prepared by the Muskegon County Convention & Visitors Bureau shall include the website address or telephone number, or both, of the White Lake Chamber of Commerce. Likewise, it is understood and agreed by the parties that the White Lake Chamber of Commerce shall do the same for the Muskegon County Convention & Visitors Bureau website and telephone.

Section 2. Reports and Auditing. Chamber agrees to maintain appropriate accounting records, and provide invoices serving to evidence services rendered by Chamber during period of the Agreement. In addition, Chamber agrees to permit County, and to fully cooperate, with County staff in their performance of an audit following completion of the fiscal year.

Section 3. Term of Agreement/Termination. This Agreement shall commence as of October 1, 2012, and continue through September 30, 2013. Provided, however, that this agreement may be terminated by either party by providing thirty (30) days written notice of intent to cancel. In the event of an early termination, the parties agree to reconcile accounts so as to assure that Chamber is funded to the extent of appropriations provided for hereunder through effective date of termination of the agreement, or notification by County of termination of agreement.

IN WITNESS WHEREOF, the parties hereto have executed this agreement as of the date above written.
