PROCLAMATION

CHILD ABUSE & NEGLECT PREVENTION MONTH APRIL 2016

WHEREAS, in 2015, Muskegon County reported approximately 1,100 victims of child abuse or neglect; and

WHEREAS, child abuse and neglect is a serious problem affecting every segment of our community, and finding solutions requires input and action from everyone in our community; and

WHEREAS, our children are our most valuable resources and will shape the future of Muskegon County, our State and our Nation; and

WHEREAS, child abuse and neglect can have long-term psychological, emotional and physical effects that can have lifelong consequences for its victims; and

WHEREAS, protective factors are conditions that reduce or eliminate risk and promote the social, emotional and developmental well-being of children; and

WHEREAS, effective child abuse and neglect prevention activities succeed because of the meaningful connections and partnerships created between child welfare, education, health, community and faith-based organizations, businesses and law enforcement agencies; and

WHEREAS, communities must make every effort to promote programs and activities that benefit children and their families; and

WHEREAS, we acknowledge that we must work together as a community to increase awareness about child abuse and neglect and contribute to promote the social and emotional well-being of children and families in a safe, stable nurturing environment; and

A Resolution In Support of 2-1-1

WHEREAS, the Flint Water Crisis has cast a light on the necessity to be prepared when disaster strikes. One service that has unwaveringly shone tremendous value throughout this situation, and which has proven worthy of state support is Michigan 2-1-1; and

WHEREAS, trends in child well-being from the 2016 Kids Count Michigan Data Book show an increase in confirmed cases of child abuse and neglect in Muskegon County and 2-1-1 is the most available crisis network poised to help families with needs that could prevent abuse and neglect; and

WHEREAS, 2-1-1 is a confidential service that is free of charge to users and provides referral agency assistance. It helps those in need of assistance in our lakeshore community of Muskegon County as well as throughout the state to connect to thousands of different human service programs; and

WHEREAS, whether it be referrals for utility, shelter and food for families struck by circumstances beyond their control, 2-1-1 has been at the helm 24 hours a day, seven days a week ready to help residents connect to necessary resources and information; and

WHEREAS, crisis support requires quality staff members and ongoing training to arm them with the necessary skills needed to provide relief. The funding increase would support training sessions, including Veterans and Military Cultural Competency training to AmeriCorps and other 2-1-1 staff; and

WHEREAS, the statewide 2-1-1 program receives only \$500,000 of its nearly \$7 million in operational costs from the state. The rest is contributed by local governments and agencies, including the United Way of the Lakeshore. This funding inequity is an unsustainable model for the future with some communities already unable to support 2-1-1 and the critical services it provides due to funding constraints; now

THEREFORE BE IT RESOLVED, that the County of Muskegon does hereby support a total of \$3.5 million from the state to the Michigan 2-1-1 network to ensure the organization's sustainability and to improve its infrastructure. This will allow 2-1-1 network to meet the state's demands for real-time information about the needs and questions residents have on a local level; and

BE IT FURTHER RESOLVED, that this funding request includes a \$500,000 fund for disaster and emergency relief that could roll over in years where it is underutilized. This will help ensure that Michigan residents in the midst of a crisis receive support immediately, when it is most needed; and

BE IT FINALLY RESOLVED, that copies of this resolution shall be distributed to Governor Rick Snyder, Senator Goeff Hansen and Representatives Marcia Hovey-Wright and Holly Hughes urging them to support the efforts to bolster the Michigan 2-1-1 network.
