Drain Commission Report

Chairman Derezinski read a statement setting forth the reason for calling for this report and what the Commission hopes to learn. (Chairman Derezinski's statement and list of questions is attached.)

County Clerk, Karen Buie, issued the Oath to Drain Commissioner, Marty Hulka.

Corporate Counsel Williams stated a brief background regarding previous events which lead to this action. David Jacobs came to the Board for help feeling that he was at an impasse to move forward with his development project. The Board is fairly limited other than to obtain information from the Drain Commissioner.

Drain Commissioner, Marty Hulka, noted he would try his best to be prepared to answer the questions he would be asked. Mr. Hulka noted he was proud of the 31 ½ years of being Drain Commissioner and working with developers and getting things turned around in three days to a week. Drain Commissioner Hulka noted he worked through two natural disasters, 1986 and 1998 and was told by FEMA that the drains were in too good of shape to qualify for erosion funding. Drain Commissioner Hulka further noted his staff has been recently reduced by half.

Chairman Derezinski proceeded with questions.

David Snider addressed the Board with issues of concern for development.

Michele May, former Drain Commissioner; John DeWolf and Tom Anderson spoke in support of Drain Commissioner Hulka.

Wayne Transler of Moorland Township noted his displeasure with response from Drain Commissioner Hulka regarding dams in his area.

Dave Jacobs addressed the Board stating his position as neutral with regard to the Drain Commissioner. In the past, 433's were processed in 1 - 7 days. Now it's indefinite. Just wants resolution and to be able to get on with his project.

Brian Chapman spoke regarding sesquicentennial celebration.

Dale Weisner voiced his pleasure with the new membership of the Road Commission.
