ADMINISTRATOR'S REPORT

2006-527 **AMEND THE FY2007 COMMUNITY CORRECTIONS BUDGET TO INCLUDE THE ESTABLISHMENT OF A POSITION TITLED "WORK CREW LEADER"**

The Administrator recommends, moved by Buzzell, seconded by Engle, to amend the FY2007 Community Corrections Budget (fund 2640-0373) to include the establishment of a position titled "Work Crew Leader," at a salary grade of NO 00170 with a range of \$14.059 to \$17.517 for the purpose of implementation of the Work Crew Program. The change in the budget is proposed at \$88,318, with an increase in the General Fund appropriation of \$50,318 with the additional General Fund monies coming from budgeted funds set aside in the Miscellaneous Contingency budget (1010-941-959020) for potential future Community Corrections Pretrial Service programming. And further move to appoint Vincent Port, currently a Community Corrections Case Manager (X18003) who is slated for lay-off effective October 13, 2006, to fill the position of Work Crew Leader at step 6, effective October 13, 2006. And further move to authorize Purchasing to obtain Request for Quotes and then purchase a new or used 15 passenger van at a cost not to exceed \$30,000 to be used in transporting offenders for this program.
