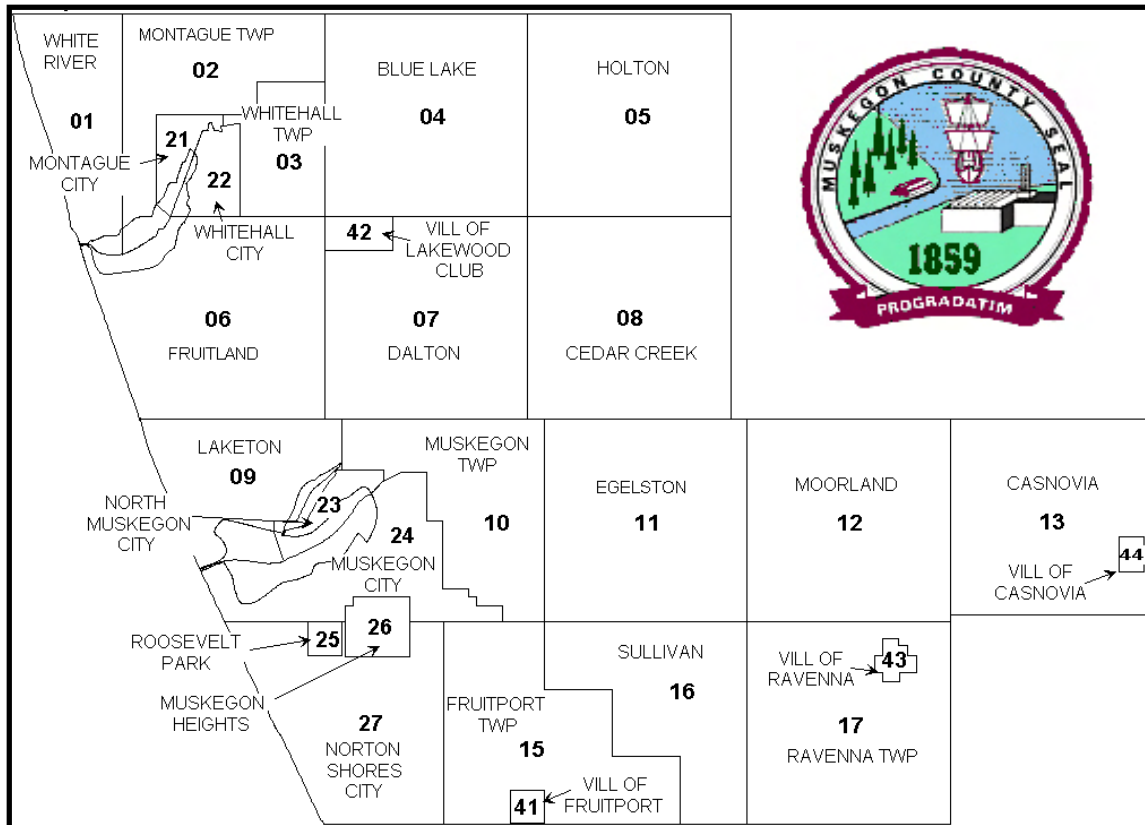

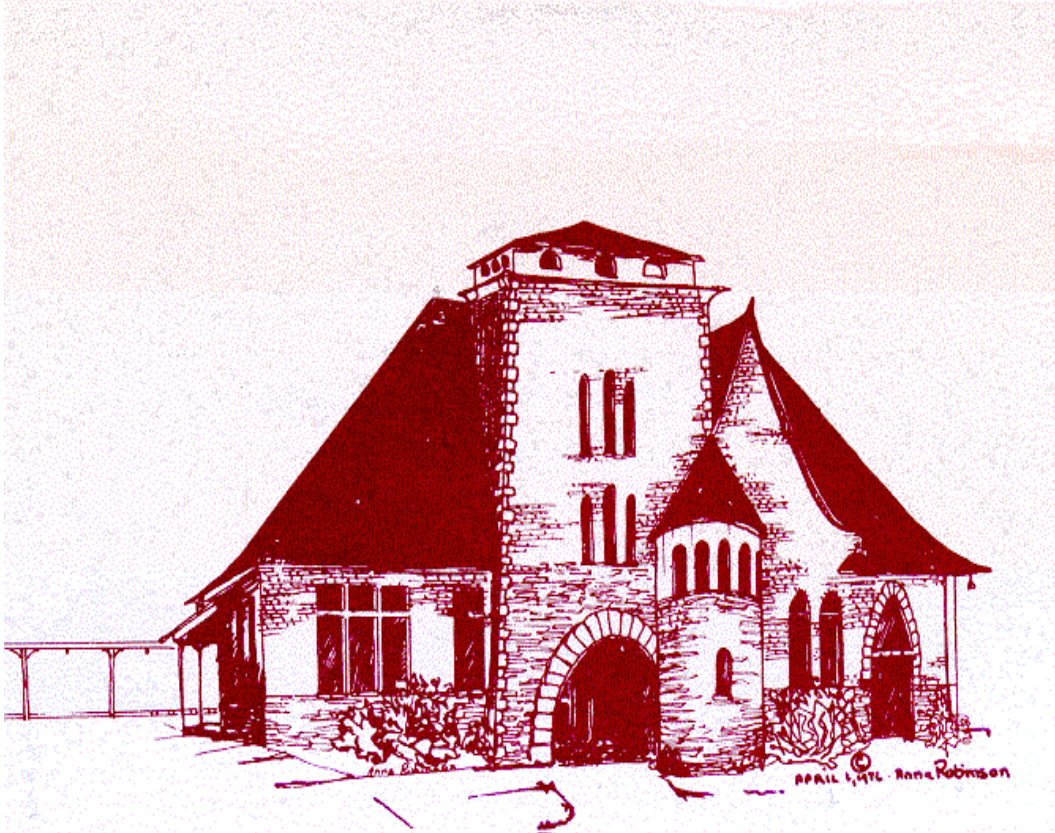

Honorable Commissioners:

As requested by the County Board of Commissioners, the Muskegon County Equalization Department has prepared this tax abatement report which contains the valuations of tax-abated property for each unit of government in a tabular format. It is the result of a collaborative effort involving all 23 assessing jurisdictions in Muskegon County. The amounts reported by these jurisdictions have been examined and internally audited. The report focuses on the value of all real and personal property subject to Industrial Facility Tax (i.e. Act#198). Obsolete Property, as well as Enterprise and Renaissance Zone Certificates, are also exempt from ad valorem taxation and are presented separately.

For 2006, the Industrial Facility Tax accounts decreased from \$192,123,400 to \$183,511,700 in State Equalized Value (i.e. SEV). This indicates a 4 percent net decrease. As for volume, there are now 346 accounts compared to 319 accounts in 2005.

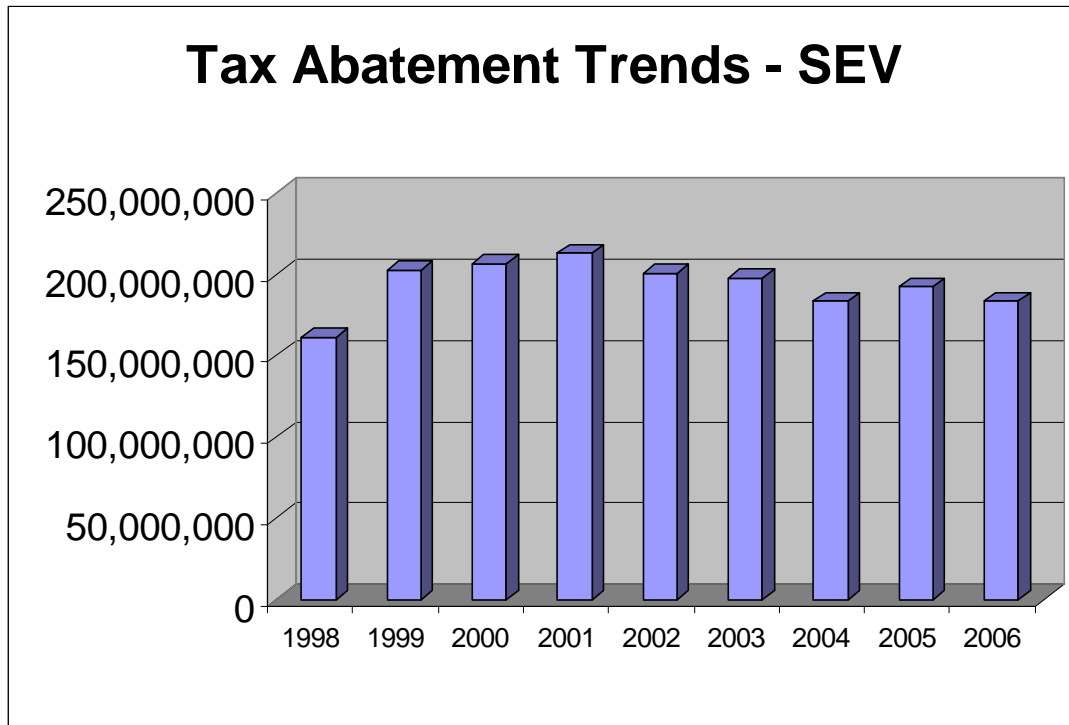
The value of all expired abatements is transferred to general ad valorem property. The abated properties now represent 4.3 percent of the taxable value of general ad valorem properties. Last year they represented 4.7 percent. The following table documents the trends.

One significant change this year was the implementation of the Tool & Die Renaissance Recovery Zones, as sanctioned by Act 276 of 2005, designated Tool & Die Renaissance Recovery Zones, being part of the Michigan Renaissance Act, P.A. 376 of 1996 (MCL 125.2688), as amended, allow the Michigan Strategic Fund (MSF) Board to designate up to 25 Tool & Die Renaissance Recovery Zones (Renaissance Zone). The MSF designated eleven Recovery Zones on December 21, 2005. Muskegon County will have nine companies within two Recovery Zones, i.e. Whitehall Township Tooling Coalition and Tooling Advantage Group.

The Tool & Die Renaissance Recovery Zones were created to foster economic opportunities and facilitate economic development through the creation of collaborative agreement amongst tool & die companies. These agreements demonstrate synergistic opportunities including sales and marketing, development of processes, standardization of tooling standards, etc.

Tool & Die Renaissance Recovery Zones are similar to previously granted Renaissance Zones in that they provide certain income tax incentives and waive all real estate taxes except for:

- a) Special assessments levied by the local tax collecting unit in which the property is located.
- b) Ad valorem property taxes specifically levied for the payment obligation of principle and interest (i.e. bonded indebtedness) approved by the electors or obligations pledging the unlimited taxing power of the local governmental unit (e.g. Schools, county, townships, etc.); therefore, the current Muskegon County Quality of Life bonding issue is to be levied against these properties.
- c) An intermediate school tax enhancement millage levied under section 705 of the revised school code (Note: not currently applicable in the County of Muskegon).

One of the distinguishing characteristics between them is that typical Renaissance Zones have a defined geographical region, i.e. an industrial park, whereas a Tool & Die Renaissance Recovery Zone is based on physical locations of companies engaged in a qualified collaborative. These collaboration agreements often are multi-jurisdictional with many crossing county boundaries throughout the state. Additionally, the duration of the Tool & Die Recovery Zones is twelve (12) years, and the tax benefits will be phased out in 25 percent increments over the last three (3) years of the Recovery Zone designation. Recent legislation has extended the duration period to fifteen (15) years upon requests from the designee.

Also new for 2006 are revisions to Public Act 451 of 1994, the Natural Resources Environmental Protection Act, as amended by Public Act 513 of 2004, revised the procedures used in the assessment, equalization, and taxation of real property owned by this State and controlled by the Department of Natural Resources. This Act basically removes the Department of Natural Resources properties (DNR) from the ad valorem roll and places them on a specific roll (“Act 513 Roll”).

The process for assessing DNR properties remains the same as 2005. The Assessment and Certification Division (ACD) of the STC will annually provide the true cash value (TCV) for each DNR parcel. Also, the 2004 taxable valuation (TV) shall be the TV of the property in 2004 through 2008, providing no acquisitions or dispositions have occurred.

All values are subject to review and revision by the Michigan State Tax Commission until October 1st of this year. There have been no other significant changes in the process for 2006. As a reminder, the taxable value limitation also applies to tax

abatement properties. All Commercial Facility Tax (i.e. Act#255) exemptions expired December 31, 1997; all Renaissance Zones became effective December 31, 2000; and Obsolete Property Abatements became effective December 31, 2001. Additionally, all expired abatements are incorporated in the equalization study process to verify proper transfer to general ad valorem property taxes.

I must commend the professionalism of our local assessors. This year there were very few problems detected during the preparation of this report.
